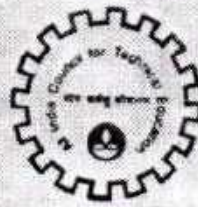

5. All infrastructural, instructional and other facilities shall be provided as per the AICTE norms prescribed from time to time.
6. Teaching and other staff shall be selected according to the procedure, qualifications, experience and pay scales as prescribed by AICTE from time to time, and that they shall be paid full salaries and allowances regularly and in time.
7. The tuition and other fees shall be charged as prescribed by the State Government within the overall criteria/limits prescribed by the AICTE from time to time.
8. The institution shall not charge any Capitation Fee or donation for admission or other higher charges from the students/guardians of the students in any form.
9. Admissions shall be made on merits and as per the norms and guidelines of the AICTE.
10. The State Government policies for admissions of SC/ST, other weaker sections of Society etc., shall be followed by the Institution.
11. Institution by virtue of the approval by AICTE shall not automatically become eligible to receive financial grants or assistance from the Central or State Governments.
12. Institution shall maintain records and books of accounts as prescribed by the Competent Authority.
13. The Accounts of the Institution shall be audited by Chartered Accountant or any agency authorised by the Competent Authority and shall be open for inspection by the AICTE or any body authorised by it.
14. The Institution shall be subject to a Special Audit and inspection as prescribed by the AICTE.
15. Institution shall furnish requisite returns as prescribed by Competent Authority/AICTE for ensuring maintenance of standards.

### **ORDER**

1. Whereas, the AICTE is a statutory body established by AICTE Act, 1987. The said Act "provides for establishment of an All India Council for Technical Education with a view to the proper planning and co-ordinate development of the technical education system throughout the country, the promotion of qualitative improvement of such education in relation to planned quantitative growth and the regulation of proper maintenance of norms and standards in the technical education system and for matters connected therewith."
2. Whereas, Section 10 of the AICTE Act prescribes the function of the Council and mandates that it shall be the duty of the Council to take all necessary steps and it may think fit for ensuring coordinated and integrated development of technical education and maintenance of standards. Further, Section 10 (k) of the AICTE Act, empowers the AICTE to grant approval for starting new Technical Institutions and for introduction of new courses or programmes in consultation with the agencies concerned.
3. Whereas, in order to discharge its duties in accordance with the provisions contained in the AICTE Act the AICTE has framed the regulations for grant of approval for starting new Technical Institutions, introduction of courses or programmes and increase / variation of intake capacity of seats for the courses or programmes of existing Technical Institutions. The AICTE has also evolved a Hand book for approval process which details out the procedure as well as minimum conditions which an Institute must fulfill in order to seek approval for either starting new Technical Institutions or for introduction of courses / programmes as increase / variation of intake capacity of seat for courses / programmes as well as existing Technical Institute.
4. Whereas, S.J.M. Polytechnic, Karnataka (I-453180211) was established in the year 1994 for running Engineering & Technology (Diploma) and EOA has been issued up to 2018-19.
5. Whereas, the Institute having deficiency and issued EOA 2018-19, was asked to appear before Scrutiny Committee (SC) to submit their compliance. The Institute appeared before the Scrutiny Committee (SC) and presented their case and Scrutiny Committee recommended 'No EOA' for AY 2019-20.
6. Whereas, the Standing Appellate Committee (SAC) was held on 16.01.2019 where the institute representatives were also present in order to submit compliance of deficiencies noted by EVC. SAC considered the evidences/relevant documents shown/submitted by the institution and the submissions of the institute's representatives. The recommendation of SAC is as under:-

**"In view of deficiencies other than area requirement, 25% reduction in intake for 2019-20 is recommended.**

**However, if the institute fails to produce certificate from the Competent Authority regarding area requirement, the original recommendation of No EOA for 2019-20 may be implemented."**

6.1 The report of SAC dated 16.01.2019 was made available on AICTE web portal for information of the Institution.

7. Whereas, the institute submitted approved building plan vide letter dated 09.02.2019. The competent authority has decided to place the same before the Committee. Therefore, the building plan was placed before the committee on 25.04.2019 and the committee recommended 'EOA with 50% reduction in intake for AY 2019-20'.
8. Whereas, since the earlier SAC was recommended 25% reduction in intake but subsequent SAC increased reduction in intake from 25% to 50%, the matter was placed before SAC on 29.04.2019 for review without calling the institute. The recommendation of the committee is as under:-

#### **Recommendation of Standing Appellate Committee:-**

**"In view of the documents submitted (Reg. architect's Certificate and approved building plans) regarding deficiencies in area, but few remaining deficiencies pertaining to library and computers, the SAC (review) recommends EOA for AY 2019-20, with reduction of 25% in approved intake."**



9. Therefore, after examining the entire matter in the facts and circumstances mentioned herein above, and in terms of the provision of the Approval Process Hand Book A/Y 2019-20 and guidelines and also the terms and conditions mentioned in the Letter of Approval, it has been decided by the Council that S.J.M. Polytechnic, Karnataka (I-453180211) be placed under 'EOA with 25% reduction in intake for the A/Y 2019-20.
10. It must be further noted that clause 6.9 of the Regulations 2018 prohibits grant of any conditional approval and clause 2.24 of Chapter II of the Approval Process Handbook 2019-20 read with clause 15 of Regulations, 2018 mandate Extensions of Approval for the Academic year 2019-20 shall not be granted after 30th April, 2019 in compliance with the order of the Hon'ble Supreme Court of India dated 13.12.2012 (CA No. 9048/2012).
