- Whereas, the AICTE is a statutory body established by AICTE Act, 1987. The said Act "provides for establishment of an All India Council for Technical Education with a view to the proper planning and co-ordinate development of the technical education system throughout the country, the promotion of qualitative improvement of such education in relation to planned quantitative growth and the regulation of proper maintenance of norms and standards in the technical education system and for matters connected therewith."
- 2. Whereas, Section 10 of the AICTE Act prescribes the function of the Council and mandates that it shall be the duty of the Council to take all necessary steps and it may think fit for ensuring coordinated and integrated development of technical education and maintenance of standards. Further, Section 10 (k) of the AICTE Act, empowers the AICTE to grant approval for starting new Technical Institutions and for introduction of new courses or programmes in consultation with the agencies concerned.
- 3. Whereas, in order to discharge its duties in accordance with the provisions contained in the AICTE Act the AICTE has framed the regulations for grant of approval for starting new Technical Intuitions, introduction of courses or programmes and increase / variation of intake capacity of seats for the courses or programmes of existing Technical Institutions. The AICTE has also evolved a Hand book for approval process which details out the procedure as well as minimum conditions which an Institute must fulfill in order to seek approval for either starting new Technical Institutions or for introduction of courses / programmes as increase / variation of intake capacity of seat for courses / programmes as well as existing Technical Institute.
- 4. Whereas, S.J.M. Polytechnic, Karnataka (1-45318021f) was established in the year 1994 for running Engineering & Technology (Diploma) and EOA has been issued up to 2018-19.
- Whereas, the Institute having deficiency and issued EOA 2018-19, was asked to appear before Scrutiny Committee (SC) to submit their compliance. The Institute appeared before the Scrutiny Committee (SC) and presented their case and Scrutiny Committee recommended 'No EOA' for AY 2019-20.
- 6. Whereas, the Standing Appellate Committee (SAC) was held on 16.01,2019 where the institute representatives were also present in order to submit compliance of deficiencies noted by EVC. SHC considered the evidences/relevant documents shown/submitted by the institution and the submissions of the institute's representatives. The recommendation of SAC is as under:

"In view of deficiencies other than area requirement, 25% reduction in intake for 2019-20 is recommended.

However, if the institute fails to produce certificate from the Competent Authority regarding area requirement, the original recommendation of No EOA for 2019-20 may be implemented."

- 6.1 The report of SAC dated 16.01.2019 was made available on AICTE web portal for information of the Institution.
- 7. Whereas, the institute submitted approved building plan vide letter dated 09.02.2019. The competent authority has decided to place the same before the Committee. Therefore, the building plan was placed before the committee on 25.04.2019 and the committee recommended 'EOA with 50% reduction in intake for AY 2019-20'.
- 8. Whereas, since the earlier SAC was recommended 25% reduction in intake but subsequent SAC increased reduction in intake from 25% to 50%, the matter was placed before SAC on 29.04,2019 for review without calling the institute. The recommendation of the committee is as under: -

Recommendation of Standing Appellate Committee: -

"In view of the documents submitted (Reg. architect's Certificate and approved building plans) regarding deficiencies in area, but few remaining deficiencies pertaining to library and computers, the SAC (review) recommends EOA for AY 2019-20, with reduction of 25% in approved intake."

- 9. Therefore, after examining the entire matter in the facts and circumstances mentioned herein above, and in terms of the provision of the Approval Process Hand Book A/Y 2019-20 and guidelines and also the terms and conditions mentioned in the Letter of Approval, it has been decided by the Council that S.J.M. Polytechnic, Karnataka (1-453180211) be placed under *EOA with 25% reduction in intake for the A/Y 2019-20.
